We suggest that to maintain Ecuador"s electricity trade balance as an electricity exporter, we continue with the energy investment plans currently issued by the Ministry of Energy and Mines. YPF Ecuador (formerly Maxus Ecuador) is operator for the Oriente Basin Block 16 project that is producing approximately 50,000 barrels of oil per day (mid-1998). Conoco was the operator for the project from its inception in 1986 to 1991 when the consortium drilled eight exploration wells resulting in the discovery of five oil fields.

Ecuador's Constitution of 2008 explicitly states that the government will promote the use of clean and alternative energy sources.
