Who will receive a \$7 billion solar grant?

Washington - Today, April 22, as the Biden-Harris Administration celebrates Earth Day, the U.S. Environmental Protection Agency announced 60 selectees that will receive \$7 billion in grant awards through the Solar for All grant competition to deliver residential solar projects to over 900,000 households nationwide.

What are the benefits of residential Distributed solar energy?

Residential distributed solar energy will lower energy costs for families, create good-quality jobs in communities that have been left behind, advance environmental justice, and tackle the climate crisis.

## Will EPA release a list of tribal governments?

EPA will subsequently release the list of Tribal governments from whom EPA has received a Notice of Intent in the next couple of weeks. The list of interested applicants for the Solar for All competition cover every state and territory in the country, exemplifying a national commitment to expanding access to clean energy.

How many EPA selectees will be able to deliver solar?

Who is eligible for solar for all?

Eligible applicants to Solar for All include states,territories,Tribal governments,municipalities,and eligible nonprofit recipients. Coalitions,led by an eligible lead applicant,are also eligible to apply to this competition. Additional detail on eligibility can be found in Section III of the Notice of Funding Opportunity (NOFO).

The federal residential solar energy credit is currently set at 26% for systems installed in 2020 and 2021.
