What is Guatemala's energy source?

This page is part of Global Energy Monitor's Latin America Energy Portal. In 2018, Guatemala derived 57.43% of its total energy supply from biofuels and waste, followed by oil (29.54%), coal (7.68%), hydro (3.22%), and other renewables such as wind and solar (2.12%).

How much energy does Energuate use in Guatemala?

in Guatemala. We hold government authorizations to provide energy distribution services within our service area until 2048. In 2018 and 2017, energy demanded by Energuate customers equaled 2,923 GWh and 2,881 GWh, respectively, which represented approximately 27.7% and 28.9% of the total energy purchased in Guatemala.

What is the future of energy in Guatemala?

Competition with the possibility of developing cheaper energy sources, such as: hydropower & natural gas. The Guatemalan government has a plan of using geothermal power to supply for two thirds of the country's energy needs by 2022. Thus reducing oil imports and stabilizing the country's energy supply.

What are the key aspects of energy security in Guatemala?

The key aspects of the energy security perspective in Guatemala are: adequacy, resilience and sovereignty. To achieve energy security in the Guatemalan case, few elements should be considered: Securing major national energy services from disruptions.

Does Guatemala produce natural gas?

Guatemala does not produce any natural gas. Guatemala consumed 89,000 bbl/day as of 2016 of refined petroleum products. Oil and gas is imported primarily from the United States and Mexico.
