How much does Lesotho government contribute to solar power project?

The government is implementing 70MW solar electricity generation project at Ramarothole in Mafeteng.

The project aims to increase access to electricity within Lesotho. This will be achieved by grid extension to industrial areas and households in peri-urban areas. Phase I (30MW) of the project is financed by a soft loan from EXIM Bank of Chinawith total contribution of USD 70.188 million.
