Next up in the more than 25 million passengers per annum category: Hong Kong International Airport. With a view to improving operating efficiency and reducing air emissions, the Airport Authority Hong Kong (AAHK) rolled out a new Ground Services Equipment (GSE) Pooling Scheme at Hong Kong International Airport (HKIA) in July 2018.

Does AAHK have a GSE pooling scheme?

Ground Services Equipment (GSE) Pooling Scheme - The GSE Pooling Scheme was first launched at the Midfield Apron in July 2018, and expanded to the North Satellite Concourse and the remote bays at the West Apron in January 2019. AAHK has purchased a fleet of over 250 units of GSE, of which 95% are electric-powered.

What is GSE pooling 2.3 scheme?

In addition to the GSE Tracking initiative, a new business model of "GSE Pooling 2.3 Scheme" ("the Scheme") is also established and commenced in July 2018. Under the Scheme, the airport operator of the HKIA buys, owns, manages and maintains the GSE and then stations them on each parking stand for RHO rental use.
