Does Indonesia have a 'just energy transition partnership'?

With the recent release of its Comprehensive Investment and Policy Plan, Indonesia now has a roadmap for its Just Energy Transition Partnership (JETP). And the big headline figure has always been \$20 billion in financing commitments from foreign partners in the United States, United Kingdom, Europe and Japan.

Can the EU support Indonesia's Green and clean transition?

Why is energy transition important for Indonesia?
