A company which defrauded solar panel ownersby selling them goods and services they did not need has been ordered to pay back its victims hundreds of thousands of pounds.

How much money has been seized from a fraudulent solar panel scheme?

Two men who scammed millions of pounds from 760 vulnerable victims in a fraudulent solar panel scheme have today been ordered to pay confiscation totalling £413,206.10.
