What grants are available for solar panels in the UK?

Solar-specific grant schemes in the UK include the following: There are currently three government grants available to help with the upfront costs of solar panel installation: ECO4:Funding for energy-efficient retrofits to fuel-poor households, or ones with occupants on certain benefits.

Who can apply for the ECO4 grants for solar panels?

You can apply for the ECO4 grants for solar panels if you're in recipient of benefitsand if you own your home, or have permission to install solar panels from your landlord if you are renting. Full eligibility criteria can be found on the ECO4 website.

Can you get a solar energy grant in 2023?

The grant opened in April 2023and will run until March 2025. It can be used to fund home improvements, such as insulation, heat pumps, double glazing, solar thermal, and solar PV panels. As of February 2024, 28% of the grants handed out have been for solar panels, so applying for the grant is worth a shot if you're eligible.

Who is eligible for solar PV panels?

To be eligible for solar PV panels, your home needs to meet these specific requirements: Have an income of less than £31,000. Currently have an inefficient heating system within the D-G energy efficiency band. Own your home and live in it, or live in private rented accommodation (requires permission from the landlord).
