

The Neo 1 Project involves the design, financing, construction, ownership, operation, and maintenance of a 20MW solar PV plant in Lesotho, in the Mafeteng district, south of the capital city of Maseru. The Project consists of 70,000 solar panels on single-axis tracker, a 33kV powerline connecting the plant to a substation, and an inverter station.
