How much money did BAPCO energies raise in sukuk?

Bapco Energies raised another US\$1 billionin sukuk in October 2018. In November 2020,Bahrain adopted a strategy for supplying homes,industry, and government buildings with natural gas.

What is BAPCO energy's rebranding strategy?

That strategy is " about consolidation of our subsidiary companies into what makes a sensible organizational construct, " including centralising business support functions including treasury.

As of 2022,Bapco Energies owned twocorporate subsidiaries and had assets of more than US\$10.2 billion. In December 2015,Bapco Energies signed an agreement with Teekay Corp.,a Canadian -based petroleum shipping firm,to build a liquified natural gas (LNG) import terminal in Bahrain.
