1. Reporting Entity and Description of the Business Suncor Energy Inc. (Suncor or the company) is an integrated energy company headquartered in Calgary, Alberta, Canada.

Is Suncor a sustainable company?

Suncor is a long-time sustainability leader in the industry and one of the few companies with 10% of our annual capital dedicated to carbon reduction initiatives. In 2022, we spent approximately \$540 million on projects aimed at lowering our carbon emissions and advancing our low-carbon energy offerings.

How does Suncor compete with other energy companies?

Suncor competes in virtually every aspect of its business with other energy companies. The petroleum industry also competes with other industries in supplying energy, fuel and related products to consumers.

How much did Suncor Energy buy total energies?

In October 2023, Suncor Energy acquired TotalEnergies' Canadian operations for C\$1.47 billion (\$1.07 billion). In North America, Suncor develops and produces oil and natural gas in Western Canada, Colorado, and offshore drilling in eastern Canada.
