How much electricity did Samruk-Energy JSC sell in 2022?

In 2022, Samruk-Energy JSC's power plants participated in electric capacity tenders held on the trading platform of KOREM JSC. As a result of the centralised tendering held on 19 November 2022, the power plants of Samruk-Energy JSC sold 2,734.4 MWof electricity at a price of 590,000 KZT/MW*month.
