

Does Switzerland have a bilateral agreement on emission reductions?

Such bilateral or plurilateral cooperation is envisaged under Article 6.2 of the Paris Agreement. To this end, Switzerland is concluding a number of bilateral treaties, which set the cooperation framework and state the requirements for recognition of the international transfer of emission reductions by the treaty parties.

What does the new CO<sub>2</sub> Act mean for Switzerland?

The new proposed CO<sub>2</sub> Act to 2030 also increases the share of emissions reductions that can happen abroad to a maximum of 40%. Energy efficiency is a key pillar of Switzerland's strategy towards reaching its energy and climate targets for 2030 and the net zero target for 2050.

How can a European Union enact an electricity agreement?

Open markets are a pre-condition for any eventual signing of an electricity agreement with the European Union. Work together with cantons to speed up permitting of energy projects of national interest. Encourage the cantons to harmonise and accelerate permitting processes, improve spatial planning for renewables, and remove legal barriers.

Are Switzerland's electricity and gas markets fully liberalised?

Switzerland's electricity and gas markets are not yet fully liberalised and there has never been public support for this despite the government's efforts. Moreover, skyrocketing energy prices due to the energy crisis have reduced support for further opening the market.
