Timor-Leste Timor-Leste is a small country (14,874 km<sup>2</sup>) in Southeast Asia, located northwest of Australia within eastern part of the Indonesian archipelago, occupying the eastern half of Timor Island. In addition, Timor-Leste includes the Oecusse exclave in the northwest of Timor Island, as well as the islands of Atauro and Jacoi.
