

What is the energy supply in Zambia?

In 2018, the TPES in Zambia reached 52 PJ. The total energy supply comprises five categories: coal, petroleum products, hydropower, bioenergy and imported electricity<sup>3</sup>). The average cumulative growth rate of the population is 3.45%, which is notably lower than the average annual growth rate of the primary energy supply of

Zambia's Energy Regulation Board (ERB) has approved a plan for an emergency increase in electricity tariffs proposed by the state power utility, ZESCO Limited. This adjustment aims to raise approximately \$15 million per month from retail customers to help fund the importation of 788 megawatts of electricity.

The Energy Regulation Board (ERB) has revised petroleum product prices upward for December 2024. Petrol will now cost K33.67 per litre, reflecting a 97 ngwee increase, while diesel has seen the sharpest rise, moving from K30.11 to K32.47 per litre. Jet A-1 has also been adjusted to K31.49 from K29.57, and kerosene will now cost
